The Clearwater Township Planning Commission, in conducting its ongoing review of the Township Master Plan, is considering the establishment of a commercial business zone along highway M-72 within the Township jurisdiction. This would involve changing the land use designation along M-72 to a depth to be determined from the Right-of-Way centerline. The resulting strip on either side of the highway would be changed from agricultural or recreational to commercial.

We believe this change could stimulate economic activity within the township, increase the property value of these parcels, and provide employment or business opportunities for local residents. We would appreciate your input as to interest for or against establishing this economic corridor. At present, no investigation of the process has been undertaken, and any action to establish such would take a minimum of a year or more.
