A RESOLUTION TO APPROVE THE BALLOT LANGUAGE  
FOR A REFERENDUM ON ZONING ORDINANCE  
AMENDMENT AND TO SUBMIT THE PROPOSITION TO  
THE ELECTORATE AT THE AUGUST 7, 2018 PRIMARY  
ELECTION

At a special meeting of the Clearwater Township Board, Kalkaska County, held in the Clearwater Township Hall, located in Rapid City, Michigan, on May 8, 2018, at 11:00 a.m.

The following resolution was made by Gaylord and seconded by Seaman, to-wit:

**Recitals**

- A. On March 21, 2018 the Clearwater Township Board enacted Amendment #8 to Ordinance No. 22, the Clearwater Township Zoning Ordinance, which amended Sections 4.03 and 9.02 of the Zoning Ordinance to provide revised lake, river, and stream regulations and revised waterfront setback regulations.
- B. This zoning ordinance amendment was published in a newspaper of general circulation in the township on April 5, 2018.
- C. Pursuant to MCL 125.3402(1) a Notice of Intent to file a referendum on Amendment #8 to Ordinance No. 22, the Clearwater Township Zoning Ordinance, was filed with the Township Clerk's office on April 11, 2018.
- D. Pursuant to MCL 125.3402(3)(c) a petition requesting a referendum on Amendment #8 to Ordinance No. 22, the Clearwater Township Zoning Ordinance, was filed with the Township Clerk's office on May 1, 2018.
- E. The Township Clerk has determined that a sufficient number of signatures appear on the petition from registered electors residing in Clearwater Township to require a referendum on Amendment #8 to Ordinance No. 22, the Clearwater Township Zoning Ordinance.

- F. Because a primary election is scheduled on August 7, 2018, the Clearwater Township Board finds it appropriate to submit this proposition to the electorate at this primary election.

**Resolution**

NOW, THEREFORE, THE CLEARWATER TOWNSHIP BOARD HEREBY RESOLVES that:

1. The following proposition, the language of which is hereby approved by the Clearwater Township Board and certified to the Clearwater Township Clerk and the Kankaska County Clerk, shall be submitted to the electors of Clearwater Township for a vote at the August 7, 2018 primary election:
