- a. Freedom Park / Old Iron Bridge relocation GFA drew up conceptual plans and cost estimates. Seeking grant funding to assist.
  - i. Nature Playscape, partnering with Kalkaska Conservation District review in 2024
  - ii. Stairs and handrails to Footbridge will need to be replaced in 2024.
- b. Gym Floor Restoration with Sports Floor Restoration is complete and volleyball floor sleeves are installed. The old Volleyball Net System has been donated to SEEDS.
- a. Heritage Park concept design approved, waiting on GFA to draw up contract and Board to sign.
- c. Lamp Post Banners
  - i. Lisa Lirones provided new vertical images. Pictures were reviewed. 4 pictures were selected for use in the banners.
