Moved by Vance, seconded by Belanger to approve paying bills from the Fire Fund, voucher number 5510 through 5524 as presented. Roll Call Vote: Johnson-Yes; Belanger-Yes; D. Grimm-Yes; Vance-Yes; S. Grimm-Yes. Motion carried.

Moved by Johnson, seconded by D. Grimm to accept the Regular Meeting minutes of April 15, 2008 as presented. All in favor. Motion carried.

Sheriff's Report: Deputy Scott Griffith was unable to attend meeting due to training requirements. Supervisor Grimm presented April 2008 report.

Guest Speakers: Diana Miller running for Kalkaska County Register of Deeds; Julie Naasko running for Kalkaska County Clerk; Margaret Learner running for Kalkaska County Register of Deeds. Tony Hefner running for State Representative.

Wally Muske from Atlas Oil & Gas Company presented proposed Oil and Gas Lease Agreement for township property. Proposed lease is a standard boiler plate lease. Township Supervisor will have township attorney look at lease prior to next township board meeting.

Public Comment: Concerned about tree tops on school property off Round Lake Road could be a huge potential fire hazard.

Planning Commission: Johnson presented planning commission report.

Moved by D. Grimm, seconded by Johnson to increase Zoning Administrator salary by \$500.00 per year. Roll Call Vote: Belanger-Yes; D. Grimm-Yes; Vance-Yes; Johnson-Yes; S. Grimm-Yes. Motion carried.

Moved by S. Grimm, seconded by D. Grimm to increase the mileage reimbursement to \$.50 per mile effective immediately. Roll Call Vote: Johnson-Yes; Vance-Yes; S. Grimm-Yes; Belanger-Yes; D. Grimm-Yes. Motion carried.

Fire Department: Moved by D. Grimm, seconded by Johnson to approve up to \$1,000 for electrical work at fire station. Roll Call Vote: Johnson-Yes; Belanger-Yes; S. Grimm-Yes; D. Grimm-Yes; Vance-Yes. Motion carried.

Moved by Vance, seconded by D. Grimm to allow fire department to purchase a flag pole \$199.00; medical burn supplies \$700.00; 10 sets of rescue gloves \$100.00; ped back board \$470.00. Roll Call Vote: S. Grimm-Yes; Vance-Yes; D. Grimm-Yes; Belanger-Yes; Johnson-Yes. Motion carried.
